

Girl Scouts was founded on March 12, 1912 by Juliette Gordon Low, when 18 girls gathered and registered for the first troop in Savannah, GA. Low believed that all girls should be given the opportunity to develop physically, mentally and spiritually.

With the goal of bringing girls out of isolated home environments and into community service and the outdoors, Girl Scouts hiked, played basketball, went on camping trips, learned how to tell time by the stars and studied first aid.

Within a few years, Low's dream for a girl-centered organization was realized. Today, Girl Scouts of the USA (GSUSA) has a membership of more than 3.2 million girls and adults, a significant growth from its modest beginnings. In fact, more than 50 million women in the U.S. today are Girl Scout alum.

We invite you to learn about our robust organization and its rich history. From our willingness to tackle important societal issues to our commitment to diversity and inclusiveness, Girl Scouts is dedicated to every girl, everywhere. Girl Scouts of Gateway Council serves more than 12,000 members across North Florida. We are chartered by GSUSA, the world's only leadership development organization for girls. We believe that every girl has the potential for success and that Girl Scouting

helps girls learn values, build self-confidence, and learn leadership skills.

Gateway Council, headquartered in Jacksonville, FL, includes 35 counties and is divided into geographic areas to best serve our girl members and adult volunteers.

Girl Scouts is a lot of fun, but it's also a business with a organizational structure.


When Low founded Girl Scouts, she understood that dedicated and dynamic leaders were vital to helping girls develop their full potential. Girl Scouts of Gateway Council is led by the Chief Executive Officer, the Board of Directors, staff, and volunteers. The combined expertise of these individuals provides the leadership to set the direction of the council and establish its governance.

The Board of Directors oversees the organizational business and the governance of the council, such as:

- Working with the CEO to determine the vision of Girl Scouting and ensuring that appropriate resources exist to implement strategic priorities.
- Establishing policies necessary for the development and advancement of Girl Scouting in the council's jurisdiction.
- Ensuring all governance documents are updated and maintained appropriately.
- Ensuring that the council is positioned in the community to achieve the maximum benefit for all girls.
- Monitoring and evaluating the organization's performance, directing resources in full support of building girls of courage, confidence, and character who make the world a better place.

One of the most powerful results of living the Girl Scout Law is the ability to exercise and recognize true leadership. Talent


- Keep abreast of developments and trends in the community in order to contribute fully to the thoughts and discussion of the particular subject matter.
